### Background:

The Middle East and North Africa Network of People Who Use Drugs (MENANPUD): is a community network of people who use drugs (or have been using drugs) in the Middle East and North Africa (MENA) region.

MENANPUD is a regional network aiming to:

- Raise the voice of people who use or used drugs and enable them to defend their rights.
- Advocate for Harm Reduction services and spread awareness about related issues.
- Unify the efforts of People who use drugs in the Middle East and North Africa region and combat discrimination.

AKALIYAT: is an association that serves as an organization for the LGBTQI+ community, focusing on advocating for their rights, providing support, and fostering inclusivity within society. The organization's mission includes addressing challenges faced by LGBTQI+ individuals, particularly in contexts where they may encounter discrimination or lack of protection due to their sexual orientation or gender identity.

LIQAAT: is an organization dedicated to reviving Maghreb heritage through the concept of liberation within Maghreb popular culture, specifically centered around non-conformist, feminist queer figures. The idea of organizing this group was initiated by a team from the LGBTQ+ community who were engaged in activities supporting solidarity and mutual aid by reviving cultural heritage to create safe spaces.

Liqa'at Group was officially founded in April 2018, following a year-long process of thoughtful planning, supportive activities, and idea-sharing sessions."







## Summary of key tasks

- To enhance the leadership skills and empowerment of these movements
- To build the advocacy capacity of sex workers' movements to effectively engage with stakeholders.
- To promote legal literacy and awareness among sex workers
- To foster peer support, networking, and solidarity among sex workers' organizations.

### The above are achieved via the execution of the below duties and functions:

- Design a comprehensive capacity-building program tailored to the needs of sex workers' movements in Morocco.
- Develop training modules, manuals, case studies, and legal guides relevant to sex workers' rights, organizational development, advocacy, and leadership.
- Conduct a series of workshops, mentoring sessions, and peer exchanges, ensuring active participation and engagement.
- Coordinate and collaborate with partners to co-design and co-facilitate training programs using <u>participatory and interactive methods</u>.
- Develop and implement monitoring and evaluation tools to assess the impact and effectiveness of the capacity-building workshops.
- Collect and analyze feedback from participants and stakeholders to inform continuous improvement as part of the M&E framework.
- Promote legal literacy among sex workers regarding their rights, protections, safe & best practicess and avenues for redress.
- Enhance the advocacy capacity of sex workers' movements to effectively and safely engage with stakeholders.
- Document the outcomes, lessons learned, and best practices from the training programs.
- Prepare comprehensive reports detailing the progress, outcomes, and impact of the capacity-building initiatives.
- Support project staff in securing and managing safe venues for conducting workshops, mentoring sessions, and networking events.
- Support in coordinating logistics to ensure smooth execution of all training activities.







- Foster peer support, networking, and solidarity among sex workers' organizations to promote collective action and mutual empowerment.
- Meet with implementing partners as required and needed.

- Developed and delivered comprehensive capacity-building program, including training modules, manuals, case studies, and legal guides.
